Bait may be used in Ant Cafe, Ant Cafe Outdoor, Antopia® Bait Stations, KM AntPro Bait Stations or other similar stations that are sold separately. Visible results will vary with the type of ant being treated, the amount of bait being used, the size and location of the colony, and the foraging distance of the ants.
