DIRECTIONS FOR USE

Shake can well before use. Hold can upright while spraying and hold about 15 to 20 cm from the surface to be sprayed. Avoid using on plastic surfaces.

Clear-out Crawling Insect Aerosol, when used according to directions, will give effective residual control of ants and cockroaches in situations such as domestic, public service, industrial and commercial areas.

Pest	Critical Comments
Ants Cockroaches	For residual control, spray as a surface application up to but not exceeding the point of run off onto surfaces and into cracks and crevices where insects are likely to rest, harbour, live and breed. Use the crack and crevice extension tube to direct spray into cracks, crevices and other hard to reach places. Clear-out Crawling Insect Aerosol can also be applied directly as a spot treatment to live insects.
